## STATUS OF THE RESOLUTIONS OF THE TWENTY-NINTH REGULAR MEETING OF THE EXECUTIVE COMMITTEE

#### I. General Information

The Twenty-ninth Regular Meeting of the IICA Executive Committee was held in San Jose, Costa Rica, on July 14-16, 2009. The Members States that comprised the Executive Committee were: Antigua and Barbuda, Argentina, Chile, Colombia, El Salvador, United States of America, Guatemala, Mexico, Peru, Dominican Republic, St. Lucia, and St. Vincent and the Grenadines<sup>1</sup>. The following Observer Members States also participated: Barbados, Brazil, Canada, Costa Rica, Jamaica, Paraguay and Trinidad and Tobago. Participating as Permanent Observers were Germany, France, Israel and Italy.

The meeting was chaired Mr. Mario Roberto Aldana Perez, Minister of Agriculture, Livestock and Food and Representative of Guatemala, accompanied by Mr. Salvador Jimenez, Secretary of State for Agriculture and Representative of the Dominican Republic, who served a Rapporteur.
