Election of a member of the Audit Review Committee (ARC)

AUDIT REVIEW COMMITTEE NOMINATIONS FOR THE 2024-2029 PERIOD

Article 3.k of the Rules of Procedure of the Executive Committee and Article III of the Statute of the Audit Review Committee ("ARC Statute") stipulate that the Executive Committee is responsible for electing the members of the Audit Review Committee ("ARC"), which was established to coordinate the examination of the accounts of the Institute by the Member States.

Pursuant to the ARC Statute, the ARC comprises three members, none of the same nationality, who serve six-year terms. At least one of the three members of the ARC shall be elected from among the candidates proposed by the six Member States that are the largest contributors to IICA's Regular Fund, and at least one member shall be elected from among candidates nominated by the other Member States.

On 31 December 2023, Mrs. Mitzila Samudio, a national of Panama, will complete her term on the ARC. Thus, the election of her successor is on the agenda of the Executive Committee's upcoming regular meeting, convened for 19 –20 July of this year.

On this occasion, the new member will occupy the position reserved for someone elected from among the candidates proposed by all the Member States, and, according to the Statute of the ARC, "...shall be a high-ranking official of the office or entity responsible for examining the accounts for the public administration of the Member State of which he [or she] is a national."

Accordingly, the Director General asked the Member States to nominate potential candidates to sit on the ARC from 1 January 2024 to 31 December 2029. In response to that request, two nominations have been received:

Canada: Mr. Martin Rubenstein Dominica: Mr. Shannon Bedminister
