II. OFFICIAL RELATIONS

2.1 Assessment of the state of the relations between the National Office and the agricultural sector's institutions with respect to the activities conducted by IICA during the year:

The IICA Office in Trinidad and Tobago continued in 1985 to maintain cordial and effective relations with the agricultural sector agencies and institutions in Trinidad and Tobago. These relations were strengthened by the following activities carried out during the year.

- a. Provision of technical cooperation services to the Ministry of Agriculture, Lands and Food Production
- b. Training of local personnel of various institutions
- c. IICA's participation in seminars and workshops organized by agricultural sector institutions
- d. Utilisation of Agricultural Sector institutions in IICA's work and training programmes.
- 2.2 Assessment of the state of relations with international agencies and the status of bilateral arrangements, technical and financial cooperation, in which the Operative Unit has collaborated during the fiscal year:

The IICA Office in Trinidad and Tobago continued to maintain cordial relations with offices of international agencies resident in Trinidad and Tobago. These include:

- a. The Economic Commission for Latin America and the Caribbean (ECLAC)
- b. The Organization of American States (OAS)
- c. The Pan American Health Organization (PAHO)
- d. The United Nations Development Program (UNDP)
- e. The Inter-American Development Bank (IDB) and

No legal instruments were signed with local agencies during the year.

2.5 Status of Country's Quota contributions to the Institute and External Resources provided by National or International agencies towards actions of technical cooperation of the Unit to the 31st December.

Trinidad and Tobago is still owing quota payments for 1984 and 1985. This has been brought to the attention of the authorities.

III. DIRECT TECHNICAL COOPERATION SERVICES

3.1 Synthesis of the problems of the agricultural sector in terms of the areas of priority for the action of IICA:

The Agricultural Sector of Trinidad and Tobago continues to show an unsatisfactory performance in spite of generous subsidies and capital investments. The food import bill increased from TT\$250.3 million in 1975 to \$904.6 million in 1982. During the last year, however, there has been some increase in local food production and it has been reported that there has been a drop in the food import bill by some TT\$40 million. These improvements have been mainly in the areas of fruits, vegetables, fish and milk production. The diversification programmes of Caroni (1975) Limited have led to the increase in the production of rice and there are plans to increase production of citrus coffee and beef in 1986. With increasing difficulty being faced by the petroleum sector the down turn in the domestic economy continues. In his Budget Speech, the Prime Minister reiterated the agricultural policy of the government for 1985 which includes:

- Redirection of resources previously used for export crops to local food production
- . 2. Discontinuation of production subsidies
 - Development of production contracts with farmers for the production of selected crops.
 - 4. Production of sugar for local consumption only.

Priority areas identified in which IICA can play a significant role are:

- a. Diversification of Caroni Lands from sugarcane into food crops
- b. Rehabilitation of the citrus and cocoa industries and improvement in the domestic marketing of food crops.

In addition, IICA's current actions in Agricultural Information and Plant Protection should be continued to support the broad agricultural diversification efforts of the Ministry.

3.2 Synthesis of the actions of technical cooperation realized by the Operative Unit in terms of its contribution towards solving the central problems in the priority areas identified with the country's authories:

During 1985, the IICA Office in Trinidad and Tobago cooperated with the Ministry of Agriculture, Lands and Food Production in three projects and two conjunctural activities aimed at attacking priority problem areas in the agricultural sector. These included the programme areas:

- 1. Plant Protection
- 2. Agricultural Information
- 3. Tree Crop Rehabilitation
- 4. Marketing
 - 1. Plant Protection: The Regional Plant Protection Project for the Caribbean is sited in the IICA office. During 1985, the project collaborated with the Ministry of Agriculture in plant quarantine training, preparation of course in post-harvest losses and training on fruit pests. Information was also supplied in the Caribbean Plant Protection Newsletter.
 - 2. Agricultural Information: Training of library staff of the Ministry of Agriculture in data input preparation, organization of the collections of the Forestry and Fisheries libraries and initiation of a national agricultural bibliography were the main contributions of this project in 1985.
 - Tree Crop Rehabilitation: This project seeks to assist in the rehabilitation of the tree crop sector. During 1985, a seminar was held to introduce farmers to the new technology of mechanization in tree crops and additional equipment was obtained to effect the mechanical spraying of cocoa for pest control. This project is being carried out in collaboration with the Faculty of Agriculture of the University of the West Indies.
 - 4. Marketing: The Ministry of Agriculture requested IICA assistance in the establishment of a marketing system for food crops. A team of specialists from IICA visited Trinidad and Tobago in August, 1985 and prepared a project document entitled "Proposals for the improvement of the domestic marketing of fruits and vegetables in Trinidad and Tobago". The report has been submitted to the Ministry and action is contemplated soon.

For 1986, the projects listed at 1 and 3 above are expected to continue. The projects listed at 2 and 4 will be terminated this year. It is hoped that funds will be provided to continue the conjunctural activity listed at 5. A new project entitled "Research on Hill Side Farming Systems in the Caribbean" will be implemented from this office in 1986 and replaced the projects listed at 2 and 4 above.

3.6 Future actions of IICA in the Country. General perspectives for new projects:

The action initiated by IICA in food crop marketing need to be followed up as the Ministry is keen on having IICA's assistance in this area on a long term basis.

PROGRESS MADE BY THE PROJECT DURING THE FISCAL YEAR

2.1 Contribution of the Results of the Year to the achievements of the Intermediate Objectives or Final Products of the Project. List concrete results, in relation to the Indicators and Steps of the Intermediate Objectives:

CARDI organized and hosted the 1985 CFCS Meeting in Trinidad. Agricultural Research Specialist participated in organizing Committee which met at CARDI Headquarters and attended the 1985 CFCS Meeting in Trinidad on September 8 to 13, 1985. The Agricultural Research Specialist attended a CARDI/CTA Seminar held at CARDI on December 3-6, 1985 and entitled "Strengthening of Agricultural Research in the Caribbean". The role of CARDI and its relationship with international agencies was discussed. The Agricultural Research Specialist prepared a bibliographic classification scheme and guide and a list of sources. Meetings were held with Miss Marilyn Drayton, Librarian at the Central Experiment Station in May 1985. After project funds were unfrozen by cable 1548 of the Director General on September 11, 1985, another meeting with Miss Drayton, Mrs. Denyse Johnson of the ECIAF Library and Hugo Caceres (IICA-Trinidad and Tobago) was held. Mrs. Denyse Johnson signed a contract in October, 1985 to compile, classify and index references for the bibliography "Soil and Water Resources and Management in the Caribbean" from 1920 - 1985. The work is scheduled to terminate on February 15, 1986.

In response to the Director General's memo OC/DG-106 of January 17, 1985, which requested the development of national projects in Trinidad and Tobago, the Agricultural Research Specialist visited Cheryl Gonsalves, Cocoa Agronomist at the Central Experiment Station and R. Burgess of

CARDI organized the 1985 CFCS meeting with Dr. St. Claire Ford as president of the organizing committee. The IICA Agricultural Research Specialist, Warren Forsythe was a member of the committee. CARDI organized a seminar on agricultural research in the Caribbean. Dr. Ralph Phelps, of CARDI was the coordinator of the meeting. The Agricultural Research Specialist participated in the meeting.

Mrs. Denyse Johnson of the ECIAF Library was contracted to compile, classify and index references for the bibliography "Soil and Water Resources and Management in the Caribbean". She received consulting support from Warren Forsythe and Hugo Caceres, Information Specialist.

Warren Forsythe met with Cheryl Gonsalves, Cocoa Agronomist at the Central Experiment Station, R. Burgess of the Tree Crops Section on February 14 and 26, 1985 and Chelston Brathwaite and Warren Forsythe of IICA-Trinidad and Tobago met with Lance Louis of the MALFP and Head of the Cocoa Rehabilitation Committee, Cheryl Gonsalves and Dr. Winston Harvey, Professor of Agricultural Engineering of the Crop Science Department of the Faculty of Agriculture of UWI, to draft a project "Rehabilitation and development of tree crop production in Trinidad and Tobago"

Warren Forsythe visited the IICA Offices in St. Lucia, Dominica, Grenada, Barbados and Jamaica in relation a situation study to prepare a project "Research on hillside farming systems in the Caribbean". During November 17 to December 2, 1985 he spoke with Colin Paul, Coordinator of Plant Propagation of the Ministry of Agriculture and David Jackson of the British Development Tree Crop Project in St. Lucia; Urban Martin of IICA, Frank Schneider of Coconut Expansion Project, Derrick Zamore, Coffee Agronomist of the the Ministry of Agriculture, Collin Bully, Director of Agriculture of the Ministry of Agriculture, John McIntyre Tree Crop Specialist of the Ministry of Agriculture in Dominica; Cosmos Joseph of IICA, Mr. Dennis Noel, Permanent Secretary of the Ministry of Agriculture, Mr. C. Borris, Tree Crop Specialist of the Ministry of Agriculture in Grenada; Rafael Marte of IICA, S. Skeete of the Ministry of Agriculture, Scotland District Project in Barbados; Vivian Chin and C. McDonald of IICA, Mr. Feitz Shaw, General Manager of the Cocoa Industry Board, Dr. D. McLoed, Director of Research and Development, Calvin Cotrell, Dep. Chelston Brathwaite and Warren Forsythe met with Dr. Thomas Carr, Director of Research of Caroni (1975) Limited on March 12, 1985 and as a result the consulting visit of Marc Berthouly of PROMECAFE to Trinidad occured during October 13 to 20, 1985. Dr. Warren Forsythe accompanied Marc Berthouly on his consulting visit.

Chelston Brathwaite and Warren Forsythe attended a follow-up meeting on February 25, 1985 in Trinidad. This meeting followed a Director of Agricultural Research Meeting sponsored by ECLA in Jamaica on December 3 - 7, 1984. During the follow-up meeting it was recommended that IICA be requested to be the administrative agency for a proposed Caribbean Cooperative Research Programme. The candidacy of IICA as administrative agency was presented by Warren Forsythe at the Directors of Research Meeting in Jamaica.

The third operative was not approved until September 11, 1985 by cable 1548 from the Director General. This has caused delays in signing a contract to prepare the bibliography, plan a visit to St. Lucia, Grenada, Dominica, Barbados and Jamaica and subsequently prepared the project document "Research on hillside farming systems in the Caribbean".

 - f. An officer of the Ministry of Agriculture in Trinidad and Tobago was trained in Acarology at Ohio State University.

2.8 Problems encounted during the execution of the Project and Recommendations for the following fiscal year:

- 1. Confusion in Ministry's identification of their priorities led to inability to implement activities which were programmed e.g. Jamaica.
- 2. The general problem of obtaining early nomination of participants for meetings has affected adversely the planning process.

2.9 General Perspectives for the Project:

The project is important for the improvement of the crop production sector in the Caribbean. Pests and disease continue to spread in the region and only effective plant protection programmes can assist in restricting this spread. Moreover, the recent decision by U.S. authorities to make it mandatory for countries wishing to export to the United States to have adequate plant quarantine infrastructure and regular surveys makes the project even more important. The countries are also embarking on fruit production programmes which will involve the

development of extra-regional markets for fruits. If these initiatives are to be successful then effective pest and disease control programmes will be necessary.

2.1 Contribution of the Results of the Year to the achievements of the Intermediate Objectives or Final Products of the Project. List concrete results, in relation to the Indicators and Steps of the Intermediate Objective:

On the 27th March, 1985, the Director of IICA-Trinidad and Tobago and the Agricultural Research Specialist met with Mr. Robert Montano, Trinidad and Tobago Agent for the "Argo" all terrain vehicle (ATV), Mr. Bob Archer, "Argo" Marketing Manager, Mrs. Cheryl Gonsalves, Cocoa Agronomist of the Ministry of Agriculture, Lands and Food Production and Dr. Winston Harvey, of the Crop Science Department of the University of the West Indies (UWI), at the "San Salvador" farm of Mr. Montano. The performance of the Argo was discussed along with possible assistance from the company in further studies and a visit of Dr. Harvey to Ontario Drive and Gear Limtied in July, 1985. As a result of an IICA sponsored report on possibilities of the Argo for cocoa mechanization, the Trinidadian Government granted the Argo duty-free status in the 1985 Budget. On the 28th and 29th March, 1985, a two-day "Clinic" on the Argo was held at the San Salvdor Farm with the collaboration of IICA, UWI and MALFP. About forty persons attended the "Clinic".

A suitable fogger applicator "Fogmist" was identified by Dr. Winston Harvey and this arrived from Germany in October, 1985. Its effectiveness with the Argo will be tried.

A two-day clinic was held on the 28th and 29th March, 1985. About forty persons attended the "Clinic".
